- The Melton & District Model Club is affiliated to the British Model Flying Association (BMFA) which arranges Third Party Insurance cover for its members who are engaged in the operation of any models. All Club members, except Social, will be insured through the BMFA.
- **Provisional Membership is granted from date of application, but this status does not allow unaccompanied model flying unless:**
  1. The applicant can prove current BMFA membership and has entered all their details on this form.
  2. 'Safe Flying' has been demonstrated by achieving a BMFA 'A' Test Certificate.
  3. The relevant MDMC membership fees have been paid in full.
- **Full Membership and Third Party Insurance Cover through the BMFA will start after:**
  1. Approval of your membership application by the Committee
  2. Issue of a signed Membership Card by the Membership Secretary
  3. The Membership Subscription is made up of two parts: (1) MDMC Fee and (2) BMFA Fee, if appropriate
- Applicants under the age of 18 years on the 1<sup>st</sup> January are classed as a Junior Member
- **Membership and BMFA Insurance is considered as Lapsed if not renewed by 31<sup>st</sup> December each year**
- **Junior and Vulnerable Adult applicants** – This application form must be signed by a parent or guardian to indicate acceptance of the M&DMC Policy on Welfare & Care of Children & Vulnerable Adults
